Dues are due as of August 1, 2008. Most of you have been waiting to hear the result of the vote to raise our membership dues. Please note the President's message on page one and the changes on page three. Dues remain the same for youth right now. Dues for regular members are \$20.00. If a member chooses to receive updrafts by mail an additional \$5.00 is added to dues. Almost every chapter has someone with email. Only UNPUBLISHED POEMS and poems not previously awarded a monty prize are eligible. A fee of \$2.00 must accompany each poem submitted (3 for \$5.00). Send cash or make checks to CFCP, Inc. DEADLINE is the last day of the contest month. Envelope must be postmarked no later than 12 midnight of that day. *Print contest month*

on outside of mailing envelope.

NOTE: In any month where insufficient entries are received, those poems which were submitted will be held over and judged with the entries for the following month.

The New United States Poet Laureate:

When Kay Ryan was a student at the University of California, Los Angeles, the poetry club rejected her application; she was perhaps too much of a loner, she recalls. Now Ms. Ryan is being inducted into one of the most elite poetry clubs around. She has been named the country's <u>poet laureate</u>. Known for her sly, compact poems that revel in wordplay and internal rhymes, Ms. Ryan has won a carriage full of poetry prizes for her funny and philosophical work, including awards from the Guggenheim Foundation, the <u>National Endowment for the Arts</u>, and in 2004, the Ruth Lilly Poetry Prize, worth \$100,000.

Ms. Ryan has taught the same remedial English course at the College of Marin in Kentfield, Calif., for more than 30 years. When asked if she thought her new position would make it harder to write, she replied, "No, uhuh. I think it will make it impossible."

She has published six books of poetry and her work regularly appears in <u>The New Yorker</u>, The Atlantic Monthly, and The New York Review of Books. One of her first duties as poet laureate is an appearance at the National Book Festival on Sept. 27 on the National Mall in Washington. More formally she will kick off the <u>Library of Congress</u>'s annual literary series on Oct. 16 by reading her own work.
